SUBJECT: - BRIEF ON TEXTILE TRAINING INSTITUTE MANAGEMENT BOARD (TTIMB)

The Nine (9) Textile Training Institutes were established under the Export Development Fund, these institutes are imparting education/training in the field of textiles, which have been transferred to Ministry of Textile Industry under the rule of business on establishment of Ministry of Textile Industry, vide its Notification No. 8(81)TID/05-P-II DATED 21/01/2008. Ministry of Textile Industry constituted a common governing board titled "Textile Training Institute Management Board" (TTIMB) comprises of the government functionaries, representatives of Textile Associations, Professionals and Textile Educationists/Technical Experts.

- O2. Textile Commissioner's Organization, Karachi was entrusted as Secretariat of the Board. The Board was assisted by additional staff appointed for the purpose of operation and execution of decisions of the Board. The administrative and infrastructure expense of the Board was to be borne by funding/grant through Federal Government. For this purpose, a PC1 was approved &a Project of Rs.38 Million was executed to assist the board for about a year but anyhow, the project was detached from the board & shifted to Ministry of Textile Industry, Islamabad
- 03. However, The functions of the board (with the help of above project team, appointed to assist the board) are as under:
 - a) The Management Board will be autonomous and will exercise administrative and financial powers in place of TDAP to monitor the Institutes in accordance with the terms & conditions given in the agreement signed by the sponsors of the projects/Associations for establishment of the institutes. However the financial assistance from EDF to the Institutes will be released through MoC and TDAP.
 - b) Course designing, benchmarking and standardization of syllabus/courses and duration of training.
 - c) Affiliations with local and foreign Training Institutes, Universities and Certification Bodies.
 - d) Training of Master Trainers.

- e) Financial support for new equipments, premises, hiring of professional faculty and accreditation, funding from EDF or any International Agencies.
- f) Development of new projects.
- g) Mergers of different institutes.
- h) Accounting and auditing of the Projects through qualified auditors/ Charted Accountants and arrangements for the same.
- i) Recurring and operating cost of institutes will continue to be met by the respective Textile Associations/EDF or any donor agency.
- j) Provide, develop, maintain and update the training mechanism of all EDF funded textile Institutes for Textile Training.
- k) Capacity building of training institutes.
- 1) Nominations of Government Representatives in the Management Committee of the Institutes.
- m) Award of Scholarships to the deserving students.
- n) Situation analysis of all such institutes with a view to giving and understanding the nature and magnitude of technical and financial input.
- o) Taking stock of information regarding staff, equipment, mandate, workload and linkage with textile industries.
- 04. The board convened 8 meetings and deliberated issues of the institute and decided to help the institute in the following areas:
 - i). Faculty Training
 - ii). Scholarship to needy students
 - iii). Equipments
- 05. Consequently on the recommendation of TTIMB, funds worth Rs.6,502,000/= were disbursed to the institutes by the MINTEX.
- 06. Textile Commissioner's Organization, Karachi is acting as a Secretariat of the Board. In order to discuss the issues faced by Textile Training Institutes, eight meetings of the TTIMB have been convened so far, the last meeting was convened on 25-10-2018.
- 07. Nine (09) Textile Training Institutes were set up through financing of Export Development Fund in early 90s.Earstwhile EPB released initial funds to these institutes under the heads of procurement of fixed assets and working capital for a few years. The

management of the institutes remained with the respective associations of the textile value association.

Moreover, as per the directives of MINTEX, TCO took over the possession of Two (02) closed EDF Funded Institutes (ITTMF & PKTI) and Textile Commissioner was appointed as Administrator of both institutes wide MINTEX letter No.1 (49)/EDPIU/ISB dated 21-08-2013, ITTMF was handed over to the two departments under Textile Division i.e. Pakistan Central Cotton Committee (PCCC) & Pakistan Cotton Standard Institute (PCSI), while as PKTI was being utilized to house the PK-GTI & NTU Karachi Campus. Currently, the building of PKTI is handed over to PHMA-IKTK, Karachi.
