Subject: - VACCINATION AGAINST COVID-19

Ministry of National Health Services, Regulations & Coordination's letter No.1-2/2021/Secy, dated 2<sup>nd</sup> June, 2021 on the above cited subject refers.

- 2. All departments (attached organizations, autonomous bodies, corporations and Companies) under Ministry of Commerce are directed to:
  - i. Ensure Covid-19 vaccination (through the Government of Pakistan's free service available on SMS number1166) of all employees (contractual, adhoc, daily wage, regular etc.) under their administrative control and their dependent family members who are above nineteen years of age before 30<sup>th</sup> June 2021 without fail.
    - ii. Appoint Focal Person and their contact details (including mobile number) for the purpose.
- 3. The requisite proforma that is to be completed for all employee & their dependents, is available on Ministry of Commerce's website <a href="https://www.commerce.gov.pk/latest-announcements/">https://www.commerce.gov.pk/latest-announcements/</a> and can be updated and uploaded online by the concerned organizations for compliance with the directive. It is to be ensured that data of all employees of the departments/Organizations etc is provided within 07 working days.
- 4. Heads of Departments/Attached Organizations/Companies/Autonomous Bodies etc. under the Ministry of Commerce shall be responsible for the above and shall personally ensure that there is no delay in submission of information as per the attached format within the deadline.




